Tab to each field to change any information. Insert and delete keys should not be used when filling in the template. If the first or last character of each field is moved or typed over, an error response is received upon entering. If this occurs, the template must be redisplayed.</p>

Itinerary must be within the 50 U.S. states

- Itinerary applies to the 50 United States, Puerto Rico, U.S. Virgin Islands, and international.
- International itinerary must be issued in the U.S., by ARC reporting subscribers.
- Itinerary must be on the same carrier.
- Itinerary must be priced in U.S. dollars. No equivalent pricing allowed.
- Only applicable for electronic tickets.
- Must be able to retrieve an electronic ticket record (ETR).
- Not valid if the PNR has more than 9 passenger names.
- Not applicable to tickets issued with an amount of FREE or \$0.00
- Not applicable to e-Tickets that have been printed to paper.
